San Bernardino County steps up drug enforcement - Part l

Farlier this month, the San Bernardino County Board of Supervisors reauthorized participation in the Southern California Drug Task Force as part of the Los Angeles High Intensity Drug Trafficking Area.

The Los Angeles High Intensity Drug Trafficking Area (LA-HIDTA) includes Los Angeles, Orange, Riverside and San Bernardino counties. The task force is aimed at disrupting drug traffic.

Combined, these four municipalities make up the 12th largest economy in the world. This fact, in conjunction with the geographic, cultural, social and economic

diversity of the area, makes the LA-HIDTA one of the biggest markets for drug use and distribution. Task force officials point out that these facts, when considered in light of the area's highly developed transportation routes and proximity to the United States/Mexico border, have made the LA-HIDTA a primary distribution, storage, and supply hub for illicit drugs destined for all the major metropolitan areas in the United States-a situation that is further exacerbated by the large rural (including local mountain communities) and desert areas that fall within its jurisdiction.

San Bernardino has provided resource support to the organization each year since 1992 at a cost of just under

\$100,000 per year. The LA-HIDTA, as well as the salaries of support resources provided by the individual counties, is funded by the United States Department Justice, Drug Enforcement Administration (DEA). It targets, investigates and prosecutes major drug trafficking organizations throughout the greater Southern California area. According to officials, the county's continued participation in the program has not only resulted in better coordination with other

Illegal dumping is destroying forest habitats

Deer Lodge Park resident Jeff Altmeyer alerted The Alpenhorn News of his discovery that local tree contractors had been caught on videotape dumping tree waste onto his property and the neighboring property, land belonging to the United States Forest Service.

According to Altmeyer the tree companies involved are B.R. Tree Service and Hammer's Mountain Services, whose personnel claimed Steve Montoya directed them to place the material on the property because "the property owner needed the chips for weed abatement." Altmeyer claimed the actions of these

Water company in shamb

Annual shareholders meeting is called a "circus"

Cedarpines Park property owners are steaming mad over what they call excessively high water bills, mismanagement and outright fraud perpetrated by the Cedarpines Park Mutual Water Company.

That anger, festering for nearly two decades, finally reached the boiling point in October 2011, when longtime property owners James Morrison and Cheryl Turpin filed a civil lawsuit against their local water purveyor. The suit alleges that the private utility's board of directors, by maintaining a nearly impossible to achieve 50 percent plus one quorum requirement to elect new board members at the company's annual shareholders' meeting, has denied other shareholders an opportunity to be elected to its board.

> One person attending the company's Aug. 3 annual

shareholders meeting, who wishes not to 1984, when the previous 20 percent plus the meeting turned into a shouting match, with shareholders and members of the company's board of directors trading accusations and insults. "Not true," recently re-appointed board Director Ron Albright told The Alpenhorn News Monday. "It wasn't disruptive, although some people (reportedly James Morrison) wanted to videotape the meeting and the board said no. Over 45 minutes was wasted over that."

In the absence of a quorum, say angry shareholders, current board members are able remain in control of the private utility. Though company officials claim that a majority of shareholders can initiate and conduct a shareholder meeting to appoint new board members at any time, Turpin told The Alpenhorn News Monday that this has never occurred since prior to

Run Through the Pines draws 350 racers

The 34th annual Run Through the Pines had a slightly altered course this year. Removing the extreme hill around Mountain High School near the finish line, which, although the distance was the same, resulted in the 5k and 10K runners having swifter times than in previous years. Some runners even claimed they had bested their own best times.

Racers came from all over Southern California and one from Kansas for this year's run. Reggie and Deborah Jackson Pickett from

tree companies, "put the community at risk." Altmeyer told The Alpenhorn News the San Bernardino County Sheriff's Department was called to the scene and "let the guy go," over his objections. Altmeyer explained the dumping was ongoing for two months and they created a road onto his property and expressed concern about liability if they took the chips elsewhere and disposed of them improperly. Altmeyer concluded, "It's a much bigger problem than they want to admit explaining tree contractors sometimes dispose of their oil waste in the chips.'

San Bernardino County Code Section 37.0201 provides criminal penalties for illegal dumping and that "anyone caught committing the act of illegal dumping faces citation and arrest."

When contacted by The Alpenhorn News, Forest Care Director Julie Crick described the incident as an "accident; it was a mistake. no intent to deface, just a misunderstanding." Crick further explained there was a request for chips for a neighboring property and "it was a misunderstanding on where they should be placed."

When asked about the logs, Crick explained the timber operator was staging to place more chips out of the material. Crick confirmed neighboring property owners asked for chips, explaining chips help keep the weeds down, help the ground retain moisture and prevent erosion. Crick voiced, "There have been numerous offers to Altmeyer to rehabilitate the site at no

The owner of Hammer's Mountain Services told The Alpenhorn News that B.R. Tree Service had borrowed one of his trucks, claiming not to have been involved and stated, "We take our material to the dump and we don't have a chipper." Owner of B. R. Tree Service Brian Linden offered, "I got hired by Steve Montoya to bring landscape chipping to Millpond Ranch for groundcover and landscaping.'

Linden explained they were dumping the material and spreading it to help control erosion and "basically the chips got dumped at the wrong location." As to the logs, Linden explained it was firewood to heat his house. Linden voiced numerous offers were made to Altmeyer to clean up the site with Altmeyer refusing and wanting to take it to court.

Linden voiced he contacted the United States Forest Service (USFS) about the incident and was told to spread the chips as ground cover and fire prevention. "Altmeyer was just being extremely difficult," Linden concluded adding, "It was 100 percent accident, just trying to landscape someone's property."

USFS Public Information Office John Miller told The Alpenhorn News trash dumping is a big ongoing problem and they "commonly try to find out who it is and make them come out and clean up their own mess." Miller explained dumping is usually done due to greed and not wanting to pay for the proper disposal of waste. Miller concluded, "If we can catch people, we will prosecute them, as well as have them clean it up.

As to the Forest Care courtesy list of contractors, CalFire Unit Forester Glenn Barley claimed, "The courtesy list is just a list of those tree contractors that meet the minimum standards to do work for Forest Care." A call to the San Bernardino County Sheriffs Department was unreturned as of press time.

Turpin's demand, Albright said, "She's offered to dismiss the lawsuit if we lower the quorum. but we can't change it because it's in our articles of incorporation that were drawn up in the 1920s. It was changed to 20 percent 20 years ago, but the Department of Corporations said it was illegal, so it was changed back to 50 per-

Noting that Cedarpines Park is a resort community Albright said, "We don't want people who don't live here to govern us, and that's why we have the 50 percent rule." Characterizing Turpin as a "troublemaker all over the mountain," Albright reminded that the company's customers are also shareholders in the firm. "They're actually suing themselves. This has put a big hole in our operating budget."

That "hole in the operating budget" includes over \$125,000 in legal fees paid to the Best, Best and Krieger law firm to defend the water agency in court since the civil suit was initiated on October 17, 2011. To offset those expenses, water company officials recently tacked-on

Those charges include \$8.17 for water consumption; \$44.64 for resident member fee: \$48.93 for resident meter charge and miscellaneous fees of \$156.56.

Malmuth has some thoughts and ideas about settling the long-festering legal dispute before it is adjudicated in a court of law. Those thoughts and more will be revealed in a future edition of The Alpenhorn News. In the meantime, a non-jury trial is slated to begin on Nov. 4 in San Bernardino Superior Court.

people. In reading the San Bernardino County Code on occupancy of short-term rentals, LAMAC member Voni Saxbury exclaimed, "One person per 100-square-feet of building area, that's unbelievable." Murray assured Saxbury the county was going to change to one person for 200-feet of building, while confirming maximum occupancy of 10-people.

San Bernardino County Code Section 84.28.030 provides requirements for shortterm private home rentals within the mountain region. Murray assured he would look into code enforcement.

The LAMAC directors then heard from Lake Arrowhead resident Ryan Reisbord with regard to a location on North Bay Road where he claims Above It All Treatment Center (Above It All) has a detoxification center. Reisbord claimed to have an eight-hour videotape showing 150 cars coming to and from the property. Reisbord expressed concern for children waiting for the school bus nearby, explaining there is no security guard. With regard to the school bus stop, Murray explained, "That's up to the school district."

Reisbord believes Above It All has 8-10 employees at the location, recalling parking problems, car accidents, car alarms, trash and

cigarette butts.

The LAMAC then heard from Sky Forest residents regarding the impact to their community when Above It All relocated to several commercial buildings on the corner of Highway 18 and Kuffel Canyon Road, as well as the Storybook Inn.

One Sky Forest resident, Kim Foltz, was brought to tears of frustration when describing she had unknowingly purchased a property right next door to Above It All and how there are 150 people all day long at the location. "It's nuts, smells like an ash tray, nightmare, encouraging the county to "hire more code enforce-

Sky Forest Water Company President Keith Binkley spoke of impact to its water company and purchasing water from CLAWA at a high cost to handle increased water usage from Above It All. Binkley also expressed concern about the impact on property values.

Murray assured the LAMAC the county had inspected the properties operated by Above It All, found no violations and found adherence to county code. The county is currently working on revising its ordinance on group homes.
